## SUMMARY AND LINK TO CORPORATE PRIORITIES

This report provides the Licensing Committee with information on the decisions taken in respect of licence applications. The information included within the report provides an overview in respect of the full range licensing but the majority of the applications relate to taxi licensing and premises involved in the sale of alcohol.

## DETAILS AND REASONING

Members are aware the Licensing Team is responsible for the administration of licence applications submitted in respect of the Licensing Act 2003, Taxi Licensing function under the duties of the Town and Police Clauses Act 1847 and the Local Government (Miscellaneous Provisions) Act 1976, the Gambling Act 2005 and a variety of other miscellaneous licensing and regulatory functions.

The Council's scheme of delegation has vested the power to grant uncontested applications with Licensing Officers in accordance with the Primary Legislation governing the activities under consideration.

The Licensing Team have dealt with a total of 630 applications during the first half of the financial year. An update on the Licensing Act 2003 activities will be undertaken at the next Licensing Act Committee
