# SUMMARY AND LINK TO CORPORATE PRIORITIES

## DETAILS AND REASONING

Traditionally, the General Licensing Committee has not had a formal work programme which sets out a schedule of reports to be received and acknowledges the importance of key aspects such as member training.

The adoption of a Forward Plan would support the work of the General Licensing Committee in a number of ways:

- the production of a formal work programme will give members a clearer understanding of their role, remit and responsibilities;
- corporate and statutory timescales (eg relating to the finalising of fees and charges) will be identified and therefore incorporated into officers' work programmes; and
- officers will have a clear focus on work they are expected to produce, being able to better plan their workload to meet identified dates / targets;

A draft work programme has been produced and is attached to this report as Appendix 1.

Although clearly linking certain workstreams to committee dates, it is intended that the Forward Pan is flexible and may be added to / amended any time of the year. It is, in essence, a working document.

The draft in Appendix 1 acknowledges that certain items will be classed as "standing" and will appear on all agendas as appropriate – these standing items are itemised at the top of the draft Forward Plan. Other issues (such as the Gambling Policy) have been identified but further work is required to establish when they should next be presented to the Committee.
