SUMMARY & LINK TO CORPORATE PRIORITIES

The Corporate Risk Register (CRR) is the cornerstone of the Council's approach to managing risk and an important element of the Performance Management System. It is the vehicle by which the Council aims to identify and address any potential risks to the achievement of all its strategic objectives. It complements the Corporate Plan and assists in managing its ongoing delivery.

The aims of this report are:

To show the progress made in implementing a range of projects and actions contained in the Corporate Plan and Service Plans which seek to address the key risks and opportunities in the CRR for 2009/10.

To present for Members' consideration a revised CRR for 2010/11 which takes account of those risks which have now been mitigated and any new or emerging risks and opportunities impacting on the Council.

RECOMMENDATIONS

That members note the progress made to address the key strategic risks during 2009/10 by reference to the mid year monitoring statement shown at **Appendix 1**.

That members consider and approve the draft revised CRR 2010/11 shown at **Appendix 2**.

DETAILS AND REASONING

Appendix 1 shows the progress made mid way through the current financial year to implement a range of projects and actions in the Corporate Plan and Service Plans that aim to address the risks & opportunities in the 2009/10 CRR.

All the projects & actions have a green traffic light rating indicating that they have been implemented or are on track. Our assessment is based on the information taken from "Ten" (the Council's performance management system) plus meetings with individual Service Heads to discuss the progress made.

Members will note that there is no update on corporate risk CR/2009/03 – 'Develop the Joint Building Project with Lancashire County Council'. When this was added to the CRR in January 2009 it was a developing issue but shortly after it was decided not to proceed with the project. This has now been removed from the revised version of the CRR.

Appendix 1 will again be updated and be reported to Senior Management Team and Members at the end of the financial year.

Appendix 2 shows the revised CRR for 2010/11. Although the CRR is a live document it is formally reviewed and revised by SMT in December each year alongside the revision of the Corporate Plan to take account of those risks which have now been mitigated and any new or emerging risks and opportunities impacting on the Council.

The revised CRR for 2010/11 contains 9 key risks; 3 of which are new and 6 that will be carried forward from 2009/10 as they remain important risk issues facing the Council.

A traffic light system has been adopted to indicate the relative importance of each risk. The new CRR contains 5 high (red) risks, 3 medium (amber) risks and 1 now considered to be low risk (green).

In line with the Council's agreed risk appetite the high (red) risks require prompt action and work is now in progress with risk owners to produce detailed action plans to mitigate those risks to an acceptable level.

IMPLICATIONS OF REPORT

The Governance Committee's terms of reference require it to oversee all aspects of governance including risk management. This report gives members the assurance that the Council's strategic risk management arrangements are effective and its strategic risks are actively managed.

The matters raised in the report are cross cutting and impact upon individual services and the Council as a whole.

WIDER IMPLICATIONS

In the preparation of this report, consideration has been given to the impact of its proposals in all the areas listed below.
