This review has come to light due to the number of incidents and crimes associated with the premises since the current Designated Premises Supervisor has been in place.

There have been a number of disturbances associated with the premises which have had the potential to escalate into major public order situations. These incidents have caused great concern for the local officers. It appears that the problems seem to stem from customers at the premises who have had too much to drink. The Police and Local Authority licensing officers have spoken with the DPS to

The Police and Local Authority licensing officers have spoken with the DPS to establish the causes of the problem and have recommended various solutions to reduce the incidents

However despite this intervention the recommendations have not been implemented and we have seen an increase in incidents and disorder.

The police feel that the current DPS is not strong enough to manage the premises and the customers and would therefore ask for her to be removed. The police have also asked for a number of conditions to be attached to the licence, along the lines of those recommended to the DPS which have failed to be implemented voluntarily. It is felt that the imposition of these conditions would help to address the licensing objectives and offer support and protection to customers and staff at the premises.

My name is Nicola Ruth Barrett and I am employed by S Licensing Enforcement Officer, a post I have held since			

My name is Nicola Ruth Barrett and I am employed by South Ribble Borough Council as the Licensing Enforcement Officer, a post I have held since December 2005 Prior to this I worked for South Ribble as an Environmental Health Technician. My current duties include monitoring the trading activities of premises providing licensable activities, to ensure that they are operating in accordance with the provisions of the Licensing Act 2003.

On Saturday 2<sup>nd</sup> August 2008 I was working with PS1506 Bushell and PS1287 Clitheroe. At approximately 01:20 we responded to a disorder incident at the Pleasant Retreat. On arrival I saw a number of police officers dealing with disorderly individuals outside the pub and went inside to speak to Lynn Birtwistle the Designated Premises Supervisor. By this time the pub had been cleared of customers, except for a few members of the DPS family who had been celebrating an 80<sup>th</sup> birthday party during the evening.

Mrs Birtwistle advised me that an incident had occurred inside the premises which escalated when the main antagonist was ejected. This was a male who she said was inside the premises without her knowledge and that he was banned from all Lostock Hall pubs through the local pubwatch scheme

Shortly before 02:00 the Police restored order in the area and PS1506 Bushell joined me inside the premises. He advised me that he had been made aware of a similar incident the previous evening and told Mrs Birtwistle that she would need to come into the Police Station the following week to look at how she was going to regain proper control of the premises.

On the morning of Tuesday 5<sup>th</sup> August 2008 Lynn Birtwistle met with Inspector Robinson, PS1506 Bushell and myself at Bamber Bridge Police Station. Following the meeting I sent a letter summarising the discussion and recommendations made to Mrs Birtwistle. I produce a copy of this letter as exhibit [NRB/1].

On Friday 14<sup>th</sup> November 2008 at approximately 13:30 I revisited the premises with PS1287 Clitheroe to check on what steps had been taken by the DPS to address the concerns raised during our meeting in early August and to gauge the response on site to the recent advice from the Crime Prevention Officer.

Mrs Birtwistle told me that she understood the brewery, Scottish & Newcastle, were going to install CCTV but was not sure when. She had contacted 2 companies who provide door supervisors but that it would cost her £400 per night and in the current climate could not afford to pay this. In the absence of door supervisors Mrs Birtwistle indicated that she was monitoring the door herself and directing smokers away from the front of the pub and into the rear yard. She added that she keeps putting up signs at the entrance saying the same thing. In respect of training, she and her partner Steve, had been on a course run by Scottish & Newcastle and were using the material from that, to train bar staff themselves. She also pointed out that the security alarm at the premises did not work and she was in discussions with the brewery about who was responsible for repairing or replacing it. During this meeting Mrs Birtwistle indicated that she had received threats of arson and that she and the local Police were taking these threats seriously

We discussed the possibility that the Police would be seeking a review of the premises licence given the current problems on site. I explained how the review process worked and suggested alternatives that she could consider, including applying to vary the licence herself to volunteer the conditions that the Police had indicated as being necessary to prevent and detect further criminality associated with the premises and its clients.

Despite beer barrels being used as missiles on the night of 2<sup>nd</sup> August 2008 and the issue being highlighted again during the Crime Prevention Officers visit, I noted a number of unsecured barrels along with waste and other portable items in the yard during my visit.

On Monday 17 November this premises was discussed at the MALT meeting. Lancashire Fire and Rescue Service indicated that they would visit to offer advice and support in terms of arson protection

I have also spoken to Tom Hill the area manager for Scottish & Newcastle to apprise him directly of the current position. He indicated that Lynn Birtwistle had only made him aware of the need for CCTV in the past couple of weeks. He was unaware that this had been raised formally with her almost 3 months ago

Premises Management Failings

I am writing to confirm the meeting earlier today at Bamber Bridge Police Station, involving you, Inspector Robinson, Sergeant Busnell and myself.

The meeting was called in response to increasing concerns among Lancashire Constabulary officers about your ability to effectively manage the Pleasant Retreat.

During the meeting the following specific concerns were discussed

- The unacceptable number of assaults and incidents that have occurred either inside your
  premises, or involve your customers in the area immediately outside the pub which have
  required significant Police resources to deal with individuals and restore order.
- The lack of control at door entry points which enables banned persons to gain entry to the
  pub, the potential for underage children or drunks to gain entry and for customers to bring
  drinks in open containers with them, contrary to your licence conditions.
- Customers being allowed to congregate freely on Hope Terrace drinking and smoking instead of being directed to the beer garden which is under your control.
- · The lack of effective or suitable CCTV.
- Competency issues among staff and a lack of formal training

The following recommendations were made during the meeting and I would urge you to give serious consideration to implementing them all.

- With immediate effect prevent customers standing outside your premises to smoke and drink and encourage the use of your rear external yard.
- Provide a minimum of 2 SIA registered door supervisors every Friday, Saturday and Sunday to control entry to the premises and prevent customers from spilling out onto the public footway to drink and smoke.
- Install a suitable CCTV system that will provide good quality recorded images of the internal licensable areas, door entry points and outside beer garden.
- Arrange for staff to receive effective training to increase their competence and confidence in respect of licensable activities, particularly the sale of alcohol

I must warn you that should you decide against implementing any or all of the above measures and further notable incidents occur that could have been avoided, or effectively dealt with had the recommendations been adopted, it is almost certain that a review application would be made by the Police

As part of our commitment to assist you in addressing these matters, I have arranged for the Crime Prevention Officer to contact you and provide guidance in respect of CCTV provision, Sergeant Bushell will provide contact details for a reputable security company who provide SIA registered door supervisors to a number of premises in this area and I have also enclosed a leaflet which details the courses currently offered at Runshaw College for those working in the licensed trade.

If you require any further information or assistance please contact me in the office and I will endeavour to help.

I am Police Sergeant 1506 of the Lancashire Constabulary currently based on the

Premises Supervisor (DPS) on 7 <sup>th</sup> December 2007, the application was made by		
Innhand Limited, the then Premises Licence Holders.

The application was to remove the DPS Kieron Newcombe and replace him with the new DPS Lyn Birtwistle

There were no police representations made at this time

On 10<sup>th</sup> July 2008 another application was received to transfer the premises licence into the name of Lyn Birtwistle.

It was during this period that the premises started to come to notice of the local police as well as the licensing unit due to the number of rowdy incidents and the number of assaults being reported.

About 01.20 hours on Saturday 2<sup>nd</sup> August 2008 I was uniformed duty carrying out licensing visits in the South Ribble area. I was at this time in company with PS 1287 Clitheroe and the Local Authority Licensing Officer Nicky Barrett.

It was at this time that I attended a report of disorder at the Pleasant Retreat Public House

On arrival there were a large number of police officers outside the premises dealing with a number of very drunk individuals, some of these were under arrest and I assisted the officers to clear the area of those that remained

It was evident that these persons had just been in the premises as some had pint glasses with alcohol in them.

After assisting with clearing the area, I spoke to a number of police officers who informed me that there had been a similar incident the previous evening and that they were questioning the ability of the DPS to control the premises.

I then entered the premises and spoke with Lyn Birtwistle, established what had occurred and advised her I had concerns regarding her apparent lack of control over the premises, to this end I informed her that I would make arrangements to speak with her at Bamber Bridge Police Station the following week.

I can say that at this time Lyn and her staff had been drinking and her husband was drunk, as he came out of the premises and began remonstrating with both Lyn and ourselves.

The meeting took place at Bamber Bridge Police Station on the morning of Tuesday 5<sup>th</sup> August 2008, between myself, Lyn Birtwistle, Niky Barret and Inspector Robinson.

### The issues discussed were

- The number of assaults and incidents that associated with the premises
- The lack of controls on persons entering or leaving the premises
- Customers congregating outside on Hope terrace
- Lack of CCTV
- The lack of competency of staff employed at the premises

As a result of this meeting a number of recommendations were made that would

hopefully assist in reducing the number of incidents and enhance the management of

the premises, these being

· Prevent customers drinking outside the premises and direct smokers to use the

beer garden

• Employ 2 door supervisors every Friday, Saturday and Sunday

• To install a CCTV system

· Arrange for suitable staff training

To enhance these recommendations we offered support by having the Crime

Prevention Officer carry out an assessment of the premises in respect of CCTV and

information re training and door supervisors

It was strongly emphasised that should these recommendations not be implemented in

some form, and there was a continuance of problems then we would have no option

but to seek a review of the premises licence.

In the weeks that followed there was an increase in incidents at the premises including

threats made to the DPS, as a result a Threat assessment Document was completed

and a personal attack alarm was provided.

Further to this I requested PS Clitheroe re attend the premises with Niky Barrett and

establish what if any of the recommendations had been adopted.

It was clear that none of the main recommendations were adopted and it is felt that this has a direct impact of the number and detection of crimes occurring at the premises.

Since the meeting with the DPS in august there have been a further 43 incidents at the premises, including rowdy behaviour, assaults and criminal damage.

There have most recently been 4 false activations of the personal attack alarm at the premises.

It is clear that despite the Police and Local Authority interventions the DPS Lyn Birtwistle has not carried out her responsibilities with regards the achievement of the licensing objectives and as such the Police now have no other recourse than to ask for a review of the premises licence

The recommendations are outlined below;

- 1. The removal of Lyn Birtwistle as DPS. If it was decided not to remove the DPS we would ask for the below conditions and a suspension of the licence for a sufficient length of time to allow the installation of the CCTV system
- 2. The imposition of conditions on the licence as outlined in the below table;

## CRIME PREVENTION VISIT TO THE PLEASANT RETREAT PUBLIC HOUSE, 2 WATKIN LANE, LOSTOCK HALL

The pub itself is situated in an area which is a Hot Spot area for Anti Social Behaviour and Criminal Damage with many of the local business being the target with windows being smashed and graffiti

On Thursday 13<sup>th</sup> November a visit was carried out to the pub by myself and Terry Burke on arrival we spoke to Lynn Birtwistle the landlady and her husband. Lynn stated that the Brewery had visited the premises whilst they were on holiday with a view to installing a CCTV system at the premises, to date this has not been done

Further enquiries to be conducted with the Brewery to ascertain the current position.

We would make the following recommendations:-

- A digital CCTV system with a 20 camera capability recordable hard drive
- On the exterior of the property 9 dome cameras to be situated on the four corners of the detached property and 1 covering the domestic yard area.
- Interior cameras to be located at entrance door to give a head and shoulder identification shots, 2 to be in the lounge area, 2 in the Pool room and 1 in the toilet corridors.
- Colour monitor to be placed on public view behind the bar.
- Alarm system it was noted that this is not in working order (maintenance in dispute between brewery and licensee) we would recommend that the repairs be completed ASAP.
- Rear Yard it was noted at the time of the visit that the rear gate was open and that there is a considerable amount of rubbish lying around including beer barrels which could all be used in the commission of crime. Ideally the yard should be kept clear of these items and the gates be secured at all times.
