Re Lancashire & Yorkshire Hotel, 249 Station Road, Bamber Bridge, Preston.  
Your Client – Mr Stanley Ian Duncan

Thank you for your letter dated 16 March 2009 requesting disclosure of documents as referred to in the statement of PC Gelson.

I will deal with the requests you have made in order:

1 – 8. Requested documents are enclosed

9. The Inc logs and crime report referred to are enclosed. With regards the e mail, that has unfortunately been deleted, however I can tell you that the enquiry prompting said e mail was unable to establish whether the offender subject of the incident had been drinking in your clients premises.

10. Copy enclosed

11. There is no statement or interview record in relation to this issue, however Inc Log LC-20090128-1558 (Copy enclosed) does deal with this issue on page 4 at 21.51 hours.

12. Inc log enclosed. There is no pocketbook entry available as PC Gelson did not "contact" your client. Indeed there is no reference within Para 19 of the statement which would indicate this is the case. The reference is that the "Police" made contact with your client and the result of that contact was heard over the radio by PC Gelson.

13. Requested documents are enclosed

14. The CCTV footage as detailed in Para 21 of PC Gelson's statement comprises a total of 11 discs each of which appears to contain around 90 minutes of footage from outside and inside the licensed premises. Due to the length of the entire footage I have extracted certain fragments to support our case and these have been compiled onto a single disc, which is enclosed. Having said this if you feel you need to view the entire

footage on all discs then we can arrange for you to do this by attending Chorley police station on a pre arranged appointment.

I have included in this disclosure, a statement from myself producing the above mentioned footage and the CCTV footage mentioned at 18 below.

15. Unsure of what is being requested at this point as there is no reference to PC Gelson being in attendance with your client in Para 21 of his statement.

16. Requested documents are enclosed

17. Copies of Inc log and crime report enclosed. With regards the minutes of the Pubwatch meeting please see the entry after 21 below.

18. Documents and CCTV copy enclosed

19 & 20. Inc log and both intelligence reports enclosed.

21. With regards the Pubwatch minutes of 2<sup>nd</sup> February 2009 see the below entry. I would however bring your attention to the first sentence at Para 27 of PC Gelson's statement, which clearly states the issue discussed was in "Private" so it would follow that this conversation would not be recorded in the minutes. With regards the pocket note book entry you request I can inform you that there was no entry made.

Pubwatch Minutes- As you will no doubt be aware Pubwatch operates as a separate body to the police and is chaired by a Pubwatch member. As such I do not believe we are in a position to supply you with copies of the minutes as they remain the property of the Pubwatch.

If you require these documents I would suggest you contact the chair of the Pubwatch and make the request of them. In any event as your client is, as I understand, a member of the pubwatch I would have thought he would have copies as requested. In any event your client should be able to provide you with the details of the current chairperson.

In addition to the disclosure as discussed above I have also included further disclosure of two further statements from Carly Higson on which we would wish to rely.

I hope I have addressed all the issues outlined in your letter and if I can of any further assistance please do not hesitate to contact me

I am Police Sergeant 1506 of the Lancashire Constabulary currently based on the Licensing Unit at Chorley, a post I have held since September 2004.


My role covers the area of Southern Division of the Constabulary and incorporates the Local authority areas of South Ribble, Chorley and West Lancashire.

My duties include the provision of an administrative function with regards applications under the licensing Act 2003, the identification of problem premises with a view to offer support and guidance and the enforcement of licensing legislation.

On 23<sup>rd</sup> February 2009 on behalf of the police at Bamber Bridge I submitted an application for a review of the premises licence at the Lancashire and Yorkshire hotel, Station Road, Bamber Bridge, to South Ribble Borough Council.

As part of the review I have been handed some CCTV footage relating to activities at the premises. The first of these was a VHS cassette showing some males in the rear area of the premises who appear to be taking drugs.

For disclosure purposes I have arranged for the footage from the cassette to be transferred to DVD and I produce this as Exhibit Ref AJB1506/1.

The second series of footage relates to the evening of the funeral of Stephen Ball in Bamber Bridge.

The footage is on DVD disc and there are in total 11 discs comprising footage both internally and externally of the premises of different cameras. These cameras are numbered 1 through 9, camera 13 and camera 16.

Each camera covers approximately 90 minutes of footage relating to the evening.

I have viewed the footage and as a result have compiled footage from 3 cameras that I feel are of evidential value in our case.

This compilation footage has been copied onto a single disc and I produce this disc as Exhibit Ref AJB1506/2.

My name is Carla Higson and I reside at the address overleaf. I am a Personal Licence Holder under the Licensing Act 2003, Pers Licence No is PELS 419 and runs from 24/4/06 to 23/4/16. In approximately November 06 I became the manager of The Lancs + Yorks Public House. Shortly afterwards on 12/3/07 Stanley Duncan became the Premise Licence Holder and at the same time submitted an application for me to become the DPS (Designated Premises Supervisor). From that date I was his manager and became responsible for the sale of alcohol and all the other licensing activities in the Public House.

In approximately October 07, after a number of disagreements with Mr. Duncan I decided to terminate my employment there. The disagreements were around the way the Premises were run on

my days off. I was concerned re underage drinking and excess noise from the entertainment. I terminated my employment and gave him my written notice, I did agree that my name could remain on the licence for a few weeks in order for him to get a replacement. After leaving the premises I did go in on several occasions socially as I knew the bar staff and people frequenting the place. ~~On~~ when I did remind Mr. Duncan that I wanted my name removing from the licence and he intimated that it was in hand. In December 08 Mr. Duncan gave me £150 (One hundred & fifty pounds) to go towards my wedding and as a thank you for allowing him to keep my name on the licence. In January or February 08 I again asked him if he had got his own personal licence, he stated that he had passed the course and that his solicitor was in the process of changing his name for mine at the DPS, and that it would be done in the next few days, from February 08 until today I have had no responsibility in the day to day running of the premises, I expected my name to be taken off as DPS after six to eight weeks. I would like to reiterate that I

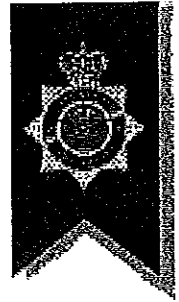

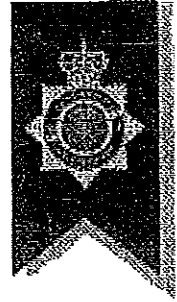

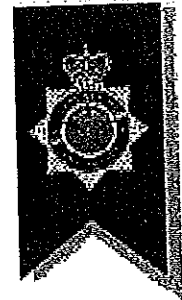
