**ANNEX 1- MANDATORY CONDITIONS**

**SALE OF ALCOHOL**

1. The Premises licence holder shall ensure that no supply of alcohol is made under the premises licence- (a) at a time when there is no designated premises supervisor in respect of the premises licence; or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended (section 19 of the Licensing Act 2003).
2. The Premises licence holder shall ensure that every supply of alcohol under the premises licence must be made or authorized by a person who holds a personal licence (section 19 of the Licensing Act 2003).

**SECURITY PROVISION**

1. The Premises licence holder shall ensure that each individual present on the premises to carry out a security activity [as defined by paragraph 2(1) (a) of Schedule 2 to the Private Security Industry Act 2001] must be licensed by the Security Industry Authority.

**ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE**

1. The operation of the store will normally be from 07.00 at the earliest to 23.00 at the latest.
2. Notices are displayed throughout the store advising 24 hour CCTV is in operation.
3. Digital CCTV cameras installed both internally and externally.
4. Tapes are retained for 31 days or if it is a digital recording system the memory lasts for 10 days.
5. Recordings are made available to police and other agencies including the local authority.
6. An Incident book is maintained at the premises.
7. All incidents are reported and monitored by Store Management and our Loss Prevention Team.
8. The frontage of the premises is provided with security lights.
9. E.H. Booths & Co takes its obligations under existing legislation seriously. However, the nature and the operation will not change during the additional hours and no further measures are considered necessary to promote this licensing objective.
10. E.H. Booth & Co takes its obligations towards children and alcohol under existing legislation seriously. This is evidenced with the introduction of procedures such as "Think 21" and refusal log.

**OFF - LICENCED CONSUMPTION**

Alcohol shall not be sold in an open container or be consumed in the licensed premises.

**OFF-LICENCES AND OFF-SALES DEPARTMENTS OF ON-LICENCED PREMISES - PERMITTED HOURS**

Alcohol shall not be sold or supplied except during permitted hours.

- (b) the sale of alcohol to a trader or club for the purposes of the trade or club;
- (c) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
