

We wish to let you know that we strongly object to the proposed Spar Development to take place in Units 1-5 Clifton Parade and the granting off a license to them to sell alcohol.

We live directly opposite the proposed development at no 48 Bristol Avenue and have been very happy here for the past 22 years. Since we learned of the application for the Spar shop to obtain a licence to sell alcohol and the fact that the shop will be open everyday 7 am to 11 pm including Xmas Day and Good Friday, we have been very unhappy and look towards the future with dread. Not only will it reduce the price of our dwelling substantially, it will reduce our privacy completely. The front door of the shop is to be positioned on unit 3, which means that everybody coming in and out of the shop will be able to look down the entrance to our front and back doors – never again will we feel that our home is in a quiet housing estate or that it will be safe. Making our entrance so public is asking for potential burglaries, and damage to our house.

Each morning we expect the thud of the newspaper drop around 5.30 am, the whines of the delivery lorries several times a week – bread, milk, provisions, alcohol, and the thud of the shutters closing at 11 pm each night. This is when we are supposed to have quality time sleeping – not being awakened by thuds and bangs from across the road.

All day, every day, we expect cars to park on the pavement outside our house which borders on to both Lever House Lane and Bristol Avenue. It is obvious that this will be the handier option for most motorists who plan to use the shop for the odd item. Not only will this cause even more noise and pollution for us, it will be a traffic nightmare as people try to turn out of Leverhouse Lane and the potential for accidents must increase substantially.

Then there is the issue of Neon lights, shining directly into our bedroom at the front of the house – in the winter time, this will be a major disturbance issue.

Added to that will be the teenagers in their cars, driving in, purchasing alcohol, playing their loud music whilst drinking it, throwing their cans and chip papers on the road, or more likely over our hedge, and then revving their cars whilst they finally exit from the car park.

Coupled with that will be the younger teenager element, trying to purchase alcohol and cigarettes, and congregating on the steps next to the shop or on the wall opposite our house. We have had this problem in the early 1980's, with gangs of kids meeting up, yelling and screaming, throwing stones and cans at our windows and doors and being complete nuisances. Several times we have had to call the police to get the kids moved on. The shop owner has assured us that he will not serve alcohol or cigarettes to them. He cannot however move them from the steps or the wall as they are not part of his shop. The possibility of this happening again is very real and we are really NOT looking forward to it.

We have spoken with the shop owner who seemed to be very sympathetic and plausible and said he would try his utmost to run the shop well. This I am sure he will do, but it will be due to his shop that we will have constant noise pollution, litter pollution, traffic pollution, young kids roaming around causing havoc, as outlined above ALL DAY EVERY DAY. He will not worry about this. He and his employees can lock the shop up and go to their homes and relax in a QUIET environment whilst WE are left with this constant, never ending, and continuous interference with our life. I would like the planners to put themselves in our situation and think this one through very carefully. Our immediate neighbours have stated that they are also very concerned. Are profit and the employment of a few people really worth disturbing this community? Would you like it if a big SPAR shop opened next to your house from 7 am to 11 pm, every day of the year? What could it do to the value of your house and its potential to sell?

We have always been led to believe that these shop units were designed for local businesses to fit around the community – not a large enterprise operating during unsociable hours.

We feel that although this community may benefit from a well stocked shop that opens regular hours e.g. 9 am to 6 pm, we are going to be the scapegoats to enable outside business people to make a profit at our social expense and that that is not fair. Does business influence have to override people's worries and concerns? We have not been consulted in any way – like we were when the proposed Indian Restaurant was an issue. We visited South Ribble offices to look at the proposed plans and development and there was nothing on the computer. Yet the owner of SPAR seems to know exactly what type of shop he is having, how the car park will look, etc. Can he just move in and create a large business without considering the welfare of the local residents? Should there not be some consideration of the local residents in business planning and development?

We think that the sale of alcohol will totally exacerbate the constant disturbance to be expected as outlined above, and because of this we completely object to the license being awarded.

We look forward to an acknowledgement of this letter and to being consulted as to the outcome of the decision.

Dear Sir/Madam,

I am writing to express my concerns at the proposed Spar store at Clifton Parade, Bristol Avenue, Levland.

I live at 58 St. Clements Ave, Farington and my property backs directly onto Clifton Parade.

Below are my areas of concern:

- The site itself has an area at the back that is an ideal hiding, congregation and drinking point for underage drinkers. Even though the shop has not opened yet, this area has become a hotspot for the local Police due to an increase in incidents of criminal damage and anti-social behaviour. I fear that if the Spar opens then the activity in this area will increase unless the access points that lead to this area are gated off.
- There is an unadopted footpath at the side of my property that is a perfect access and escape point for would be offenders that may target the Spar. This footpath is not on any council maps and would become obsolete if the Spar owners are willing to gate their access off. This can easily be done as the part they own is classed as private. There has also been incidents of sexual offences at this location in the past.
- I am concerned about the environmental effects of the delivery times to the shop as I believe that the rear of the shop (directly behind my property where my children sleep) is the proposed delivery point. The delivery times will be varied and no doubt the times of newspaper and milk deliveries will be in the early hours. Therefore I strongly object to deliveries at these early times.
- There is the possibility of increased traffic in the area both at the front of the proposed shop on Bristol Avenue and the possibility of vehicles driving at speed into St. Clements Avenue, which is a Cul-de-sac, and using this as an access point to the shop unless of course the Spar owners block off the access. I also have concerns about the traffic management at the front of the premises and that this may become a congregating point for stereotypical boy racer types.
- There are many vulnerable people in the area as well as a local primary school and I also have concerns for the elderly and the children if there was an increase in those wishing to use the Spar to commit crime and nuisance. I feel this kind of shop attracts gangs of youths who may purchase alcohol and roam the streets of this quiet residential estate. Once inebriated either under the influence of alcohol drugs or peer pressure, could then proceed to commit crime and nuisance, including criminal damage for example, broken windows and graffiti.
- There is also a high possibility that there will be an increase in the amount of litter deposited both around the vicinity of the proposed shop as well as through out the residential estate.
- I have serious reservations at the proposed opening hours of 7-11, every day including Good Friday and Christmas Day, as I feel that these are excessive and should be reduced. There is no need for these opening times and while I know that other similar stores have these opening times, consideration must be given to the area where the proposed shop would be i.e. a quiet residential estate and not a main thoroughfare.

Whilst the shop could be a welcome development compared to the current site, where, at the moment we have a letting agent that does not care about the area and an absent landlord, I feel that there must be a number of interventions be put into place before the problems begin of which CCTV and the

gating are a priority.

I would appreciate it if you could look into these areas for concern as a matter urgency and should you wish to discuss this matter further please do not hesitate to contact me.
