ANNEX 1- MANDATORY CONDITIONS

**SALE OF ALCOHOL**

1. The Premises licence holder shall ensure that no supply of alcohol is made under the premises licence- (a) at a time when there is no designated premises supervisor in respect of the premises licence; or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended (section 19 of the Licensing Act 2003).
2. The Premises licence holder shall ensure that every supply of alcohol under the premises licence must be made or authorized by a person who holds a personal licence (section 19 of the Licensing Act 2003).

**SECURITY PROVISION**

1. The Premises licence holder shall ensure that each individual present on the premises to carry out a security activity [as defined by paragraph 2(1) (a) of Schedule 2 to the Private Security Industry Act 2001] must be licensed by the Security Industry Authority.

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

Risk assessments to be made and regularly reviewed for activities taking place on the premises.

The premises will remain open for a minimum of 30 minutes after the sale of alcohol during this time only background music will be played to allow drinking up time and providing a 'wind down' period for customers to leave the premises in an orderly fashion.

Risk assessments to be made of events and functions at the premises to ensure safety and no risk of over crowding.

Fire fighting equipment to be maintained and inspected annually.

Live entertainment and dancing including Karaoke and DJ Hosted music to end at times shown (unless otherwise de-regulated) following which background music only permitted.

All windows and doors (other than external security doors) to be kept closed during any live entertainment or performance of recorded music other than incidental or background music.

No amplified music to be relayed into outside drinking area.

Outside drinking area to be closed for sale/consumption of alcohol at 23.00 hours.

Prominent and clear notices to be displayed at all exits requesting customers *'to respect the needs of local residents and to leave the premises and the area quietly'*

Proof of age scheme adopted.

Children not permitted after 21.00 hours unless part of an organised function or event and accompanied by an appropriate adult.
