The CCTV monitoring system will be installed at the premises and it will meet the following criteria: cover public areas of premise, cover main entrance to the premise, cover the shelves with alcoholic drinks, system will be recording during opening hours and recorded media will be held for minimum of 31 days, CCTV signage will be displayed at the entrance to premise. ✓

c) Public safety

There will be risk assessment carried out regularly by the Premises Licence Holder. All the fire precautions will be considered at the premise. ✓
There will be first aid kit available at the premises. ✓

d) The prevention of public nuisance

The activity of premises does not involve noise or any smell production, opening hours are not till late, so there should be no disturbance to neighbourhood area. ✓
There will be litter bin placed outside the shop. ✓
All the wastes will be disposed regularly. ✓

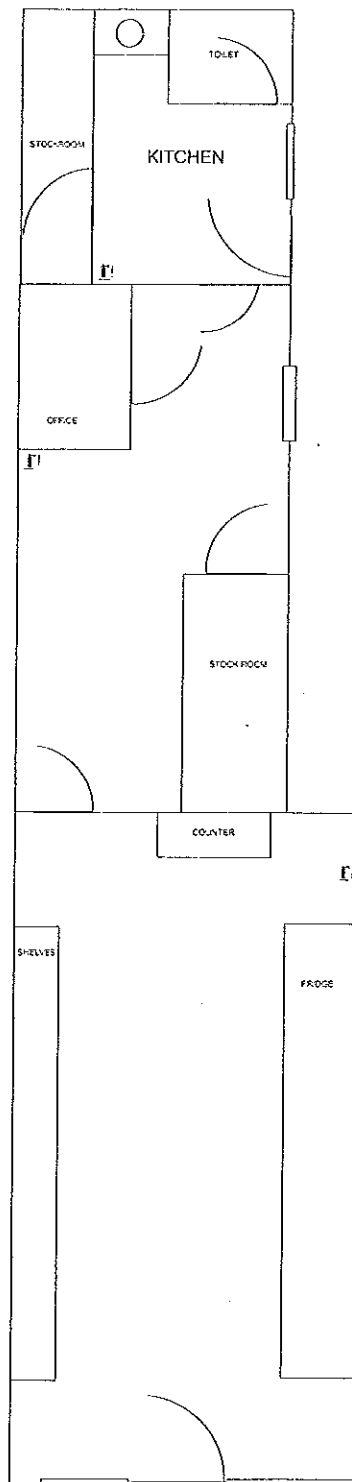
