ANNEX 1 - MANDATORY CONDITIONS

SALE OF ALCOHOL

1. The Premises licence holder shall ensure that no supply of alcohol is made under the premises licence-
(a) at a time when there is no designated premises supervisor in respect of the premises licence; or
(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended (section 19 of the Licensing Act 2003).
2. The Premises licence holder shall ensure that every supply of alcohol under the premises licence must be made or authorized by a person who holds a personal licence (section 19 of the Licensing Act 2003).
3. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

1. Regular liaison with the Police at an appropriate level shall be achieved and maintained.
2. Any CCTV recorded images shall be made available to the Police.
3. The store refusal book shall be made available to the Police.
4. Regular training shall be given to all staff, and retraining if necessary.
5. The DPS shall be the store manager, and the most senior employee on the premises.
6. The premises shall be safely maintained for both staff and public.
7. The alleviation of public nuisance shall be contributed to in the immediate vicinity of the premises by properly considering the hours of operation and sale of age-related products.
8. Any noise or light pollution from the premises shall not be overly obtrusive.
9. Policies for the regular training of employees to prevent the sale of alcohol to under 18s shall be in place.
10. A refusals register shall be maintained.
11. Employees shall actively challenge customers under 21 to prove their age by providing photo identity cards.
12. There shall be no adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children.
