#### SUMMARY AND LINK TO CORPORATE PRIORITIES

An application has been received from Lancashire Constabulary for a Review of the Premises Licence at Spar 222 Hoghton Lane, Hoghton, Preston, Lancashire PR5 0JH

The current premises licence holder and designated premises supervisor (DPS) is a Mr Waqar Mahmood. The premises came to the attention of the police following a joint operation with the UK Border Agency (UKBA) and it was found that the premises were employing persons who are unlawfully in the UK and who are not entitled to work. The Police believe that the employment of such persons is a criminal offence and can have connections with organised crime.

The Police believe that that the licensing objective of preventing crime is being undermined.

The application could have an impact on several of the Council's Corporate Priorities. It should be borne in mind however, that the application must be determined in accordance with the Licensing Act 2003, Council's Licensing Policy Statement and the statutory guidance issued under Section 182 of the Licensing Act 2003.

#### RECOMMENDATIONS

The Sub-Committee conduct the hearing in accordance with the hearing procedure and decide accordingly.

#### **DETAILS AND REASONING**

Attached is a copy of the Application form detailing the grounds that the Police have for concern. In addition the Police have provided a witness statement from Dawn Robinson from trading standards detailing possible links with other problem premises.

On Friday 28<sup>th</sup> September a joint operation took place at the premises at 222 Hoghton Road, Hoghton, Preston, Lancashire. It was discovered that two males where working within the premises that had no legal right to live or work in the UK. They were arrested and detained by the UKBA.

At the time of the meeting a male known as Mr Shabab Khalid came to the premises and informed the Police that he was the manager. The Police state that Mr Khalid was very uncooperative and further enquiries revealed that he was an associate of Waqar Mahmood (the premises licence holder) and that they were involved in other premises across Lancashire. Other illegal immigrants have also been arrested at some of these premises and there are allegations regarding the sale of counterfeit goods.

The Police have real concerns about the ownership and management of these premises. They state that it is evident that they are employing illegal immigrants and feel that no suitable conditions could be put on the licence to address the impact of the licensing objective of preventing crime and disorder and ask that the Committee to revoke the licence.

#### Representations from Responsible Authorities

Environmental Health have submitted a representation supporting the Police request and outline 5 previous complaints received over the last 12 months.

#### Representations from Interested parties

A letter of support for the premises licence holder has been received from the Solicitors acting on his behalf setting out the history of ownership to the site and other business interests and denying the allegations raised by the Police. They also question whether the allegations relate to the implementation of the Licensing Act.

#### Licensing Act 2003

The Council must carry out its licensing functions with the intention of promoting the licensing objectives.

The licensing objectives are:-

- a) the prevention of crime and disorder;
- b) public safety;
- c) the prevention of public nuisance; and
- d) the protection of children from harm.

The Council must also have regard to:

- 1. Its own Policy Statement;
- 2. Secretary of State guidance (Section 182 of the Licensing Act 2003).

#### The Legislation

Under Section 52 Licensing Act 2003 the Authority must have regard to the application and any relevant representations and take such steps ...(as are outlined below)... if any, as it considers necessary for the promotion of the licensing objectives.

The steps are:-

- a. to modify the conditions on the licence
- b. to exclude a licensable activity from the scope of the licence
- c. to remove the designated premises supervisor
- d. to suspend the licence for a period not exceeding 3 months
- e. to revoke the licence.

Obviously the Committee can also choose to do nothing for example if the application is frivolous, vexatious or repetitive and the Committee must ensure that any action they take is proportionate to the four licensing objectives.

## Procedure for all hearings before Licensing Panel to determine applications made under the Licensing Act 2003

#### **Preliminary Points**

It has been agreed by Licensing Committee that, in addition to the Declaration of any personal or prejudicial interest (in accordance with the Local Government Act 2000):-

- Any member in whose ward an application premises is situated will declare this and will not take any further part in the hearing of the application
- Any member of a Licensing Panel who wishes to either support or oppose the
  granting of a licence either personally or on behalf of their constituents, must
  attend either as a supporter of the application or as an objector and sit in the
  public gallery. The panel on which that member serves may not hear the
  application
- Subject to section 100A of the Local Government Act 1972, the panel may
  exclude the public from all or part of a hearing where it considers that the
  public interest in doing so outweighs the public interest in the hearing, or that
  part of the hearing, taking place in public. This will include, at the discretion
  of the panel the exclusion of the public during its deliberations and its decision
  making.

#### **Hearing Process**

- 1) General Introduction by Chairman.
- 2) In accordance with the Regulation 23 of The Licensing Act 2003 (Hearings) Regulations 2005 the Chairman of the panel will lead the discussion.
- A Licensing Officer will briefly outline the application for the licence and the procedure to be followed in the hearing.
- 4) Applicant(s) Case

The objector(s) and/or their representatives and the panel may ask questions of the applicant and/or their representatives.

5) Objector(s) Case(s)

The applicant and/or their representatives and the panel may ask questions of the objector(s) and/or their representatives.

6) The Chairman will then ask the applicant if, in light of the representations, they wish to amend the application. The panel will only consider the application laid before it during the decision making.

#### 7) Summing up;

- i) Objector(s) Case(s)
- ii) Applicant(s) Case

#### 8) Conclusion

The Chairman will ask the Licensing Authority Legal Representative whether there are any other matters to be raised or resolved before the hearing is closed for deliberations.

#### 9) Deliberations

Generally speaking the public and the applicant will be excluded when the panel is determining the hearing decision. Once a decision has been reached all parties will be readmitted to the hearing. At this stage the chairman will announce the panel's decision and will give reasons for the decision.

#### 10) Notice of Decision

All parties will be notified of the decision at the earliest possible opportunity.

Please provide as much information as possible to support the application (please read guidance note 2)

The premises subject of these review proceedings were licensed under the Licensing Act 2003 in November 2005 for the sale by retail of alcohol. The current premises Licence Holder is Waqar Mahmood who is also listed as the Designated Premises Supervisor.

On Friday 28<sup>th</sup> September 2012, officers from the UKBA attended Off licence premises at 222 Hoghton Lane, Hoghton and carried out a raid on both the shop and living accomodation located above the shop. Due to the premises being licensed for the sale by retail of alcohol the police licensing officer accompanied the UKBA officers on the raid.

On entering the premises officers found 2 males in the shop premies, one of these was behind the counter serving, the second male was found in the security office of the premises.

Checks carried out on these two males revealed that they were both illegally in the country in that they were "overstayers". as such they were arrested and detained by UKBA officers, there were no other staff in the premises at this time.

The DPS was not present at the premises however a short time later a male entered the premises stating he was the manager. This male stated his name was Shabab Khalid and he was informed as to reason for the visit and what had been found.

At this point Khalid became very un-co operative with both the police and the UKBA officers, refusing to assist in establishing the circumstances surrounding these individuals being employed at the premises.

Khalid was advised re his lack of co-operation and that this was not something we would expect of a person who was in charge of a premises especially one retailing alcohol.

Further enquiries revealed that Khalid is an associate of Waqar Mahmood and that they are involved in other "Off" licensed premises in Lancashire. Khalid is in fact the Premises Licence Holder and Designated Premises Supervisor of a premises at 455 St Annes Road, Blackpool as well as being the Designated Premises Supervisor at premises located at 40 Larkholme Parade, Fleetwood. The premises licence holder at these premises is listed as WWS Retail (UK) Ltd, the director of which is Waqar Mahmood.

Prior to attending the premises subject of this review, UKBA officers conducted a raid at the premises located at 40 Larkholme Parade on Wednesday 19<sup>th</sup> September 2012, where they detained 2 males illegally employed at the premises. One of the males was an "overstayer" the other was found to be working in excess of hours permitted on his visa. These males were arrested and detained by the UKBA and the premises will be subject of review proceedings.

At time of writing all 4 males are still in UKBA detention pending removal from the UK.

The police would raise grave concerns over what appears to be a course of action involving Mahmood, Khalid and associates in the employment of illegal persons in premises owned or controlled by them. The employment of these individuals attracts fines of up to £10,000 per individual employed and it is clear as to why Khalid was reluctant to engage with the police and UKBA.

In reality the employment of illegal workers is criminal activity and can be linked to cases of people trafficking and modern day slavery. Illegal workers are often forced to work excessively long hours for very little renumeration, they are often accomodated in poor conditions sleeping on floors with very little hygiene provisions.

The persons involved in employing these individuals have a major impact on the local economy, in that they do not pay the required taxes etc normally associated with employees wages and the fact that these people are employed restricts the job opportunities for people in the local area.

In submitting this review the police have considered what sanction they would recommend to address this situation. It is felt that no conditions could be attached to the licence which would address this issue, nor would the removal of the DPS as they can just be replaced. The Police therefore have no alternative but to request full revocation of the premises licence.

Premises Drinks Express, 260 Colne Road, Burnley- sometime licensee Khalid Pervez, sometime DPS Waqas Mahmood. On 19 July 2010 two packs of Golden Virginia tobacco bearing foreign health warnings were sold to a test purchaser acting for this service. On 4 February 2011 nine bottles of illegally diverted non-duty-paid High Commissioner whiskey and Glens vodka were seized. On 3 October 2012 one pack of counterfeit Golden Virginia tobacco bearing foreign health warnings was sold to a test purchaser acting for this service. Proving business ownership has not been possible.

Premises 117 Regent Street, Nelson. Occupier Imran Zafar. On 19 July 2010 two packs of illicit tobacco bearing foreign health warnings were sold to a test purchaser acting for this service. On 16 June 2012 a quantity of non-duty-paid alcohol was seized by HMRC during a joint operation.

Premises Eccles & Eastwood/ Parvez Brothers, 145 Leeds Road, Nelson. On 6 December . 2011 five packs of illicit Jin Ling cigarettes bearing foreign health warnings were sold to a test purchaser acting for this service. On 12 December 2011 five packs of illicit Jin Ling cigarettes bearing foreign health warnings were sold to a test purchaser acting for this service, and seven packs of the same were subsequently seized from the shop. On 14 January 2012 a visit found that no A3 tobacco notice aimed at preventing the sale of tobacco to under 18s was displayed. On this occasion occupant Ranja Ahmed stated that Waqar Mahmood was the owner. The DPS at the time of these occurrences was Khalid Parvez. Waqar Mahmood stated that he owned the building but rented the business for cash to another. He did not provide contact details for the man responsible.

We are instructed on behalf of WWS Convenience Store Limited and Waqar Mahmood who is the Premises Licence Holder for the above premises. We understand a Premises Licence Review has been commenced by Lancashire Constabulary and have seen a copy of the proceedings issued in this matter.

WWS Convenience Store Limited operates the premises. Wagar Mahmood is a director and shareholder of WWS Convenience Store Limited The Company operates a number of Off Licence Convenience Stores under the Spar brand generally in the north-west but including premises in Bradford and Burton on Trent.

The WWS Convenience Store Limited is a family company. The Company has over the last 15 months sought to grow the number of sites operated by it by way of acquisitions.

The premises the subject of the Review was the first of those acquisitions. Prior to the acquisition by WWS Convenience Store Limited the premises had been operated by the father of the family.

The store was acquired in early 2011.

WWS Convenience Store Ltd are responsible for the employment (whether on an employed or self-employed basis) of staff at site.

Waqar Mahmood is the DPS at site and one of the Directors and Shareholders in the Company that operates the premises.

WWS Convenience Store Limited also operate the site at 40 Larkholme Parade, Fleetwood and also operate premises at 455 St. Annes Road, Blackpool. Both are referred to in the Review proceedings.

It is denied that WWS Convenience Store Limited or Waqar Mahmood knowingly employed or allowed individuals to work at site who did not have the correct status. It is further denied that WWS Convenience Stores Limited were involved in the employment of illegal workers.

It is acknowledged that certain of the individuals referred to in the proceedings were working at the sites in question and further details will be given in due course as to the specifics of such of the status of each of these individuals from a work point of view.

WWS Convenience Store Limited currently employs in excess of 60 people across a number of different stores and operations and further details of those employees and the status of those employees will be provided in due course.

For the avoidance of doubt this representation is in opposition to the Premises Licence Review issued by the Police and in support of Waqar Mahmood the Respondent of the Review proceedings. Further documentation will be supplied in due course.

WWS Convenience Store Limited and Waqar Mahmood question whether the allegations in the Review relate to the Licensing Act 2003. There is no adverse comment raised as to the implementation of Licensing Laws at the site.

As the general store to a small semi-rural suburban village we take our responsibilities very seriously. Please see below for how we approach each individual point.

Staff are trained particularly with respect to prohibition of sale of alcohol to minors.

C.C.T.V. monitors in store. Locked cigarette and alcohol store separate from retail shop.

Cigarettes only available from kiosk within store.

Beer stored within full view of the cash point.

Spirits for immediate use are stored behind the cash point.

The store has one main entrance/exit and two emergency exits. In store fire extinguishers.

This is a long established general store serving the local community. Parking is available locally. Historically we have no problem with queues either inside or outside the store.

Children have no access to the area where cigarettes or spirits are stored. The beer is stored close to and in full view of the cash point. All staff are trained concerning prohibition on sale of alcohol and cigarettes to children. Likewise with solvents and lighter fuel.


