ANNEX 1- MANDATORY CONDITIONS

SALE OF ALCOHOL

- 1. The Premises licence holder shall ensure that no supply of alcohol is made under the premises licence- (a) at a time when there is no designated premises supervisor in respect of the premises licence; or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended (section 19 of the Licensing Act 2003).
- 2. The Premises licence holder shall ensure that every supply of alcohol under the premises licence must be made or authorized by a person who holds a personal licence (section 19 of the Licensing Act 2003).

SECURITY PROVISION

1. The Premises licence holder shall ensure that each individual present on the premises to carry out a security activity [as defined by paragraph 2(1) (a) of Schedule 2 to the Private Security Industry Act 2001] must be licensed by the Security Industry Authority.

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

Operating Schedule

No customers carrying open or sealed bottles shall be admitted to the premises at any time that the premises are open to the public.

A sign will be displayed on the premises indicating the standard hours during which the sale of alcohol is permitted.

All fire doors will be maintained effectively self closing and shall not be held open other than by approved devices.

Notices detailing the actions to be taken in the event of fire or other emergencies, including how the fire brigade will be summoned, are to be prominently displayed.

When amplified musical entertainment is taking place inside the premises after 22.00 windows and doors, save for entrance and exit purposes, will be kept shut.

A sign will be located at the exit(s) requesting that customers leaving the premises do so quietly and with consideration to neighbours.

No one under the age of 16 will be allowed to enter or remain on the premises after 22.00 save on Christmas Eve and New Years Eve.

Anyone who appears to be under the age of 18 and who is attempting to buy alcohol must be require to produce proof of age before such sale is made.

Background music at a reduced volume will be allowed between midnight and 01.00.

The DPS or his representative shall undertake external noise assessments whenever regulated entertainment is being provided, to ensure that noise generated at the premises is controlled so as not to cause nuisance to nearby residents. Such assessments should be documented and record retained for 12 months.
