## Vision and Priorities of the Cabinet Member

#### Housing

To ensure there is high quality housing provision across South Ribble to meet the needs and aspirations of both current and future residents, and to support the development of healthy, sustainable and prosperous communities.

#### Public Health

To work with Partners in improving the health and wellbeing of the borough.

#### Young People

To work with partners to offer the best possible opportunities for the borough's children and young people.

#### **Community Safety**

Through the Safer Chorley and South Ribble Community Safety Partnership, work to tackle crime, fear of crime and promote public confidence.

#### **Portfolio Achievements**

- Number of affordable homes built 97.
- Disabled facilities waiting list reduced and all the passported funding from Lancashire County Council allocated.
- New Health and Wellbeing Partnership formed including South Ribble, Chorley and Preston. Partnership priorities and work streams currently being developed.
- Successful funding bid to Better Care Fund for £30,000 to support enforcement of private rented sector and home insulation grants.
- New Children's Partnership Board (CPB) formed including South Ribble, Chorley and West Lancashire. This replaces the South Ribble Children and Young People's Trust Board.
- CPB Action Plan for 2015/16.
- Summer Activities booklet produced targeting young people in the borough.

- Requirements of new Anti-social Behaviour, Crime and Policing Act implemented.
- Counter Terrorism Act Action Plan produced in accordance with new Prevent duty.
- Funding successfully obtained from Office of Police and Crime Commissioner for a number of projects.
- Community Safety Partnership Action Plan for 2015/16.
- Funding continued for PCSO's and Domestic Violence including IDVA service.
- Overall crime figure for 2014/15 reduced by 8.1% and is on track for a reduction in 2015/16.

### **Portfolio Areas for Development / Improvement**

• Loneliness & Social Isolation (Scrutiny Review) to be further developed to assess scale of the issue within the borough; impact on partners and identification of where intervention achieves greatest benefit.

## Future Portfolio Challenges / Emerging Key Issues

- National housing policy is still emerging and this will impact on the local housing market.
- Future security of passported money from Lancashire County Council to address Disabled Facilities need.
- The need to look at quality of build for affordable housing not simply numbers.
- There are no extra care housing schemes in South Ribble. Given the demographics of the Borough there is a need to keep pressure on Lancashire County Council to deliver a scheme.
- Provision of health facilities to match an increasing population.
- Maintaining positive crime figures as public sector budgets reduce.
