Christmas in Western Parishes 2017

Decision:

To grant permission to allocate and spend core funds of upto £910 to contribute to one of the priority projects from the Western Parishes Neighbourhood Plan, Christmas in Western Parishes.

## Details and Reasoning:

This project aims to once again support community Christmas events in the local area. This complements the work of Parish Councils, Churches and community groups during the festive season.

To fund the production of a Christmas events guide (as produced in the last 2 years) and to fund the delivery to every household in the Western Parishes. In 2016 a copy was delivered to every household and some great feedback was received on this, particularly by homes far out.

1) The "What's On Guide" would be the same format as last year, and would include details of community events such as church services, carol concerts, switch-ons and markets.

Distribution will be to all the homes in the Western parishes via a distribution company, as well as schools and churches. Costs have been received from 2 different companies.

- 2) Support to Christmas light "switch ons" and refreshments. Purchase of mince pies as a contribution.
- 3) Support Longton Methodist Church with their Christmas Tree Festival by sponsoring a Christmas Tree and decorating it.

## Proposal

Cost of production of the What's On Guides, 7,000 copies, A3 folded to A4, upto £500.

Delivery to 6187 homes upto £250 Mince pies cost upto £100

Christmas tree festival cost £60

TOTAL cost upto £910

Wider Implications (Financial, Legal, Equality & Risk): Funding for the projects is available from Western Parishes core funding. It reflects the wishes of the local people as the guide was well received last year. There are no equality issues to consider
