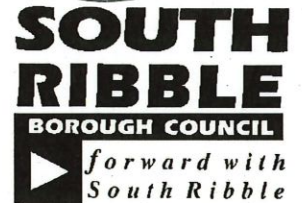

Subject:	Lostock Hall Academy Arts Trail
Decision:	To allocate up to £990 from core funds to fund the carving & installation of two 4Ft wood sculptures.
Details and Reasoning:	<p>The second & completing phase of works at St Catherine's Park will take place during Autumn/Winter 2017. This phase includes the installation of link paths, an events space, a new landscaped play area & an Arts Trail which will link the park together from its starting point at the Mill café to the WW1 War Memorial on Lostock Lane.</p> <p>Working with Lostock Hall Academy the trail has been designed using young minds as inspiration. A trail of butterflies (based on the St Catherine's logo) will stretch the hearts, minds & legs of people passing through the area & (hopefully) raise funds for the vital work of St.Catherine's Hospice.</p> <p>The aim of the project is to increase visitor numbers to the park & increase the levels of participation of young people in the scheme, which will encourage & support inter-generational work right across the project.</p> <p>In support of the overall funding proposal for the Arts Trail (see Appendix 1) the Central Neighbourhood Forum are being asked to fund the cost of the two signature 4ft carvings, one of a butterfly to begin the trail & one of a kingfisher to end the trail.</p>
