Permission to spend section 106 funds allocated to the Western Parishes Neighbourhood Forum to support New Longton Car Park

Permission to allocate and spend section 106 funds (M3/150 Land of New Manor Residential Home, Liverpool Road, Longton) of up to £550 to support New Longton Car Park.

## Background

The Western Parishes Neighbourhood Forum have been approached by New Longton Sports and Social Club for assistance with upgrading of the club car park. The car park is open to use by the general public, as well as members of New Longton Sports and Social Club and new Longton Cricket Club. It is well used by people using the adjacent playground and other community facilities in the area. The car park is central to the village.

The car park is owned and maintained by South Ribble Borough Council. Patching work has been suggested, rather than having the whole car park resurfaced.

## **Proposal**

A quote has been received from Red Rose to carry out pothole repairs where there are three large potholes and several small potholes, and the following has been suggested and quoted for:

- Cut out each pothole square
- Fill with tarmac
- Seal each pothole to prevent water getting in
- All waste removed
- 2 men, 1 day, all materials

It is proposed to carry out this work during a quieter period of time, when the cricket season has ended and during the week in term time.

## **Details**

To fund £550 plus VAT to carry out the repair work on the car park to make it safer and easier to use.
