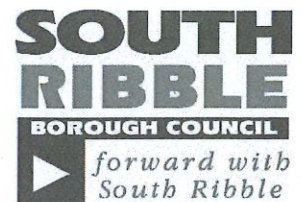

Subject:	Permission to spend core funds allocated to the Central Neighbourhood Forum to improve the entrance to Bashall Grove at its junction with Mill Street.
Decision:	Permission to allocate & spend core funds of up to £500 to improve the entrance to Bashall Grove at its junction with Mill Street.
Details and Reasoning:	<p>Background</p> <p>At recent meetings and forums, Borough and Parish Councillors, and local residents have suggested that the two areas of council owned land on Mill Street which form the entrance to Bashall Grove in Farington should be improved to provide a more welcoming view for both residents & visitors to the area.</p> <p>Details</p> <p>In order to gauge local opinion and to move the project forward, local residents were asked to complete a brief survey to let us know what they thought of the idea & tell us about the features they would most like to see included.</p> <p>Taking these results in to account, and considering the comments, thoughts and ideas of Borough and Parish Councillors a scheme was costed & drawn up by engineers at South Ribble Borough Council.</p> <p>Following their approval of the scheme, Farington Parish Council have agreed to allocate £1500 from their funds. The Central Neighbourhood Forum have been asked to contribute £500 so that the scheme can be developed & and delivered in partnership with the Parish Council.</p> <p>Proposal</p> <p>In line with the details given above, the proposal is to allocate up to £500 from core funds to improve the entrance to Bashall Grove at its junction with Mill Street.</p>
