	In order to gauge local opinion and to move the project forward, local residents were asked to complete a brief survey to let us know what they thought of the idea & tell us about the features they would most like to see included.
	Taking these results in to account, and considering the comments, thoughts and ideas of Borough and Parish Councillors a scheme was costed & drawn up by engineers at South Ribble Borough Council.

	Following their approval of the scheme, Farington Parish Council have agreed to allocate £1500 from their funds. The Central Neighbourhood Forum have been asked to contribute £500 so that the scheme can be developed & and delivered in partnership with the Parish Council.
